Wildfires in the Area

We are thinking of those members of our community whose families and friends are affected by the recent wildfires in our area. We may see patients evacuated from wildfire areas.

Wildfire hazards come in several forms. Particle pollution results from particles in the smoke, with 90% of the particles 2.5 microns or less in diameter, known as PM2.5. Cardiovascular and respiratory effects result from exposure to PM2.5, with greater

risk in those with asthma, COPD, bronchitis, chronic heart disease or diabetes. The risk of health effects is elevated in the elderly or young children, pregnant women, outdoor workers or those of lower socio-economic status. Another threat is carbon monoxide (CO) which binds to hemoglobin with 200-300 times the affinity of oxygen, decreasing oxygen transport to the tissues. Binding of one molecule of CO at one Hgb binding site increases the affinity of oxygen to Hgb at other binding sites, causing left shift of the

oxyhemoglobin dissociation curve and decreasing tissue unloading, worsening tissue hypoxia. Partial pressure of oxygen (PaO2) and pulse oximetry may be normal in patients with CO poisoning. Symptoms may include headache, malaise, altered mental status, shortness of breath, seizures or cherry red lips. A carboxyhemoglobin blood test is diagnostic.

Commemorating Our Women Physicians on National Women Physicians Day

On February 3, National Women Physicians Day marks the significant and rising contributions of women in the medical field. Providence St. Joseph Hospital is proud to salute our 327 women physicians, who constitute 31.8% of our Medical Staff, and invite them to participate in the Women Doctors of Orange County networking group.

"When I left New York to join SJO's Medical Staff in 2000, as part of my welcome I was introduced to the hospital's Women Doctors of Orange County (WDOC) networking group. Since then, some of my closest friends and colleagues are from there," shares Dr. Laura Tangredi, a Family Practice physician in Batavia Woods. "It was a great way to meet people, and as a primary care physician, I really appreciated meeting new doctors from many specialties.

"Since our post-covid resurgence, the group's four chairs aim to each take one event a year. Our peak attendance so far has been about 50 women in one of our larger venues. At our first meeting in 2024, we toured the new Helen Caloggero Women's & Family Center. We've also met in some of the doctors' homes. Dr. Linda Zeineh did a lecture about newest and emerging plastic surgery techniques. In December we met at the Mining Company in Orange for a lovely dinner, white elephant gift exchange, and a lecture from the event's generous sponsor, Natera, on screenings for oncology and other diseases. Each doctor introduced herself with a fun fact. Participation was fantastic and it was lots of fun."

She adds, "What a great way to keep informed, keep up with technology, and network with fellow women physicians from numerous specialties. It benefits patients by facilitating care coordination. When I contact a specialist, she knows who I am. My patients will sometimes ask me, "Do you know Dr. so-and-so,

and I've been able to say, 'Yes, and she's phenomenal.""

The group welcomes new Medical Staff women physicians, and may in the future open it to other Providence ministries. "Our current goal is to reach every woman physician on staff," she says.
